If mailed to Albany the county receives nothing, but if taken or mailed to Warsaw the County receives 12%. It will help to support our local DMV.

Supervisor Gozelski also stated that work will be started in late 2010 at the hospital. It is a 22 million dollar job and money will be bonded for it. Work has also begun on the old medical center in Warsaw and should be completed in the next year or so.

PWMS N. Kibler presented the Board with his monthly report; he stated that everything is going well for this time of year.

Dep. Highway Superintendent D. Nourse stated that because of the mild winter they are able to get more ditching and tree trimming done. He also stated that he contacted Burt's Lumber to get quotes on overhead doors. They quoted \$895.00 per door and \$70.00 per opener if they do all 4 doors. They are also checking into pricing for the grates on the shop floors that he would like to replace because of safety issues.
